Dick Lake's broken right hip is healing but he is still only able to walk (with a walker) for short periods of time.



Some controversy here, therefore my question is in two parts (if you can count that high).

(1) According to our local SIR rule I may drop a ball in bounds and BEFORE my next shot am I now lying two or three?

(2) Just where should the ball be dropped?

Dear Hazard:

You REALLY OLD coot! Your cruise should be the Super Senior Tour! It has been a while, I knew I was really enjoying myself.

As to your alleged golf question, haven't you ever heard about a provisional? Let me tell you, one more time, if there is any chance that your ball is out of bounds or lost, hit a provisional! It takes very little time and saves a lot of grief. Incidentally you should identify the first ball and the provisional to your playing partners so if a ball is found, everyone will feel quite comfortable as to whether it is the first ball or the second.

As might be the case for you, if the provisional ball goes only fourteen feet, and the first ball 200 yards before it neared the out of bounds, you can keep hitting the provisional without being committed to use it, until you have reached the area as far out as the first ball. Then you should look for the first ball and if found in bounds play it, pick up the provisional even though it took, say seven strokes for you to get there.

Now back to your question, if you have not hit a provisional and you find that your ball is out of bounds, you have the special SIR only rule which says: **TO AVOID GOING BACK TO THE TEE AND HITTING ANOTHER BALL YOU MAY DROP ANOTHER BALL AT A SPOT NEAR TO WHERE IT WENT OUT OF BOUNDS OR WAS LOST, AND ADD TWO PENALTY STROKES**. 


