

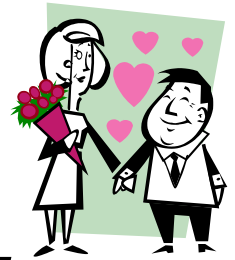

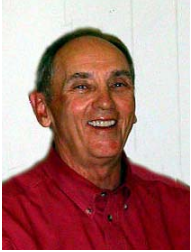

Wind and weather conspired to keep most of the fishing group off the water this past month. There were several planned trips to Ryer Island in the Delta, which were canceled, because of cold water conditions and too much debris and flotsam for the stripers. But, we're all not wimps – in mid-January Tom Hensley, member John Wall and guide John Berry fished the American River near Upper Sailor's Bar and Tom boated a 12 pound steelhead — that's his biggest. He also landed an 8 pound sucker (from whence the phrase "that's one big sucker"). So, there was actual fishing going on this month!!!

(led by Ed Dijkman) from setting the entire fishing calendar for the year in place.

Its off to the Sportsmen's Exposition in Sacramento on January 20th - always a heavy favorite with our members. Along with gear, beautiful boats and more boats and exotic trips to far off places tickle the fancy. We have a full contingent going there. Similar shows in San Mateo (February 3 – Rich Bal Fishmaster) and Pleasanton (February 25-Don Mittelstaedt Fishmaster) are set, and many will attend one or more of these.

For those, who are "newbies" (haven't ever fished, fished years ago and not since, etc), the Fishing Group is working up an introductory seminar for you in March or April. This would be taught by people from Creative Sports Fly Shop in Lafayette and/or Hogans Sports in Concord and would be designed to explain the basics, detail what's available and how to start. Creative Sports already has a 2 hour fly fishing class at Heather Farms Monday through Thursday (and elsewhere over the weekend), wherein they furnish gear and instruction for those interested in getting their feet wet in this aspect of the sport. Cost is only \$55. If you want to get involved in that way, you can contact Lois Kilburn at (925) 938-2255 for further information. As far as the Fishing Group's "newbie seminar", look for further details in this column.

As far as the calendar for the next 3 months the Fishing Group has a day trip (one or more) to McAvoy's (Pittsburg) in the Delta for stripers; day trip to San Pablo Reservoir for trout on February 23 (Tom Hensley is Fishmaster); guided trip to Oregon for steelhead on March 16-19 (Ed Dijkman is Fishmaster); trip to Angels Camp for the "Glory Hole Fishing Seminar" on April 1-2 (covers how to fish in the foothill area); and a day trip to Clear Lake/Berryessa in late April. Much more is planned but this summarizes the next 3 months.
