The lunch and bridge group met on February 13th with 28 men joining in. This was the highest scoring day the group has ever had. High man was **Bill Sullivan** with **9,840** points ! An astounding total. **Jack Butler's** second place total of 7,080 points didn't stand a chance, even though it would have been a runaway winner any other day. In third place was **Jai Yee** with 6,720 points, enough to win on most other days. **Charley Schmidt** was in fourth place with 4,480 and in fifth place was **Roy Hedtke**. **Ken Harold** had two small slams, first with **Jack Butler** and then with **Jai Yee**, but they were not enough to land him within the top five places.

All SIR members and guests are welcome and, indeed, encouraged to participate in fishing trips as well as attend the monthly meetings. Next meeting will be March 22nd at the Legend Sports Bar and Grill at the Diablo Creek Golf Course at 4050 Port Chicago Highway in Concord. Meeting starts at 8:30 am.

There was not a lot of fishing done in January and February. The most interesting adventure was an ice fishing trip to Lake Davis lead by **John Hayes** who was joined by **Joe Karg, Pete Gates, Paul Dubow, and Don Mittelstaedt**. These intrepid adventurers fished on Friday, February 9th in the afternoon and Saturday, February 10th in the morning, on the ice, in the RAIN!!!! Only one fish was caught, a pretty 3 pound rainbow caught by **Don Mittelstaedt**. In what may be a SIRS first, all 5 fisherman were from different SIRS branches. **Carl Moyer** reported a successful trip to Lafayette Reservoir catching 4 nice rainbow trout. He also ended his 2007 sturgeon drought by catching a 50 inch sturgeon near the mouth of Montezuma Slough. He credits the good luck to bringing along **Joe Karg**. While Carl has fished 10 times without a keeper sturgeon, Joe has over a hundred hours on the water without a keeper, and now believes he qualifies as a professional observer and good luck charm. Many of the fisherman attended the fishing and boating shows and expos occurring this time of the year. They enjoyed themselves looking at all the new boats and gear. The consensus was that the Sacramento show was by far the largest and best.

The outing to a Seminar in Lodi planned on March 24<sup>th</sup> has been canceled. A house boat ad-

venture on Lake Shasta with **Joe Karg** as fishmaster is scheduled for April 22nd through the 25th. A Day at the Races is planned for April 26<sup>th</sup>. **Bob Olson** is fishmaster. In May there are adventures to McSwain Reservoir, the Pitt River, Lake Almanor, trips to the American River for Shad, fly fishing for trout in the lower Sacramento, Norden/Soda Springs for trout. A family social at an Irish pub is planned for June. Quite a busy year ahead, the fish are in big trouble.

We would like to remind everyone that 2007 licenses are required, and the sturgeon rules are expected to change March 1st. At this time it appears that the slot limit will change from 46 inches up to 72 inches, to 46 inches to 66 inches. Also there is a proposed punch card limiting fisherman to 3 sturgeon annually. The punch card is planned to be free and available at many outlets.

## Honoree of the Month Milt Greenstein

He is Bridge Chairman for the 4th year. Milt joined SIR in 1991, sponsored by Fran Kohles. Married for 56 years to wife Marge, he has two sons and one daughter, two grandsons and one granddaughter, and has lived in Moraga for 42 years and in Lafayette for 10 years before that.


Born in Hampton, Iowa in 1925, Milt grew up in Waterloo, Iowa, and graduated from Iowa State University in 1946 with a BS degree in Civil Engineering. He came to Oakland in January 1947, met Marge in Berkeley in December 1949 and got married in July 1950.

He went to work for Bethlehem Steel Co. in Lackawanna, N.Y. for 5 months after graduating college in 1946. It took 5 months of heat and then cold to realize that there were better places to live than Buffalo, N.Y., so he quit and came to California. Milt worked for EBMUD for 6 years before quitting and started working for construction companies. He went to work for McGuire and Hester, an underground pipeline construction company for 3 years, then Gordon H. Ball, Inc. for 22 years and then Ball, Ball and Brosamer Inc. (a successor company) for 15 years before retiring in 1988 as Vice President and Chief Engineer. He worked as a project engineer, foreman, superintendent, project manager, estimator and chief estimator. The last 2 companies were heavy engineering companies involved in the construction of highway, airport, canal, tunnel, rapid transit, hydro power plants and dam projects throughout the U.S, and specializing in concrete paving, as well as mass excavation, concrete bridges and other concrete structures.

After retiring, Milt kept busy with sporadic consulting work (still doing some of that), volunteering for charitable work, playing golf and bridge, traveling (have been to all 50 states and to over

90 foreign countries), helped build stage sets for Playhouse West, and helping his wife around the house with the gardening (all the weeding), housework and the maintenance (the honey-do's), and is the pro-bono "maintenance engineer" for his congregation's facility in Berkeley: he says staying busy helps keep him out of trouble.
